

MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING is made the day Wednesday, 8th February, 2023

WHEREAS HELP University Sdn Bhd (Co. No. 198201005211), (hereinafter referred to as "**HELP**") of 15, Jalan Sri Semantan 1, Damansara Heights, 50490 Kuala Lumpur, Malaysia, is a University engaged in education and training; and

WHEREAS **UNIVERSITAS ISLAM NEGERI ALAUDDIN MAKASSAR (UINAM)** of Indonesia, established in 1965, an educational institution duly organized and existing under the laws of Indonesia, located at Jl. H. M. Yasin Limpo No. 36 Romangpolong Gowa, South Sulawesi, Indonesia; of the other part

WHEREAS HELP and UINAM (hereinafter referred to as the '**Parties**') recognise that collaborative efforts will be of mutual benefit and will contribute towards an institutional linkage for education co-operation and assistance.

NOW, THEREFORE HELP and UINAM agree to continue discussions as opportunities arise to ascertain the extent to which cooperative activities could be implemented in the future.

The Parties agree to mutually look into the following areas of cooperation:

1. Setting a HELP Branch Campus/Study Centre in UINAM;
2. Collaboration on developing cooperation in UINAM for promoting Undergraduate and Postgraduate programmes;
3. Collaboration on managing Executive & Professional Development Programmes;
4. Organize Joint Conference and Forum;
5. Engage in recruitment of students for HELP University in UINAM;
6. Develop and implement effective strategy for promoting Student Mobility;
7. Cooperation in Staff development programmes;
8. English training programme;
9. Undergraduate and Postgraduate programmes;
10. Professional & Executive Education programmes;
11. Student Recruitment;
12. Student and Staff Exchange;
13. Joint Research;
14. Study Abroad Programme (1 semester to 1 year at HELP University);
15. Staff Development;

16. Other areas of mutual interest in educational projects.

This Memorandum of Understanding shall commence on the date of signing and operate for an initial period of three years.

This Memorandum of Understanding shall not serve as a legally binding agreement. This understanding is not to be construed as a partnership or any form of master-agent relationship. It is merely to forge good relationship and understanding between the parties hereto.

The PARTIES and their representatives should not during their association, use or divulge, directly or indirectly any trade secrets or confidential information which may have come to their knowledge, whether or not by accident or by mistake without the express permission of the other party.

The details of any specific joint activities arising as a result of further discussions pursuant to this Memorandum of Understanding will be set forth in an Agreement, the terms of which are to be agreed upon by the parties hereto and to be signed at the relevant time by the respective parties.
